

Wizeprep Terms and Conditions

Your purchase, enrollment in and use of products, services, and events (collectively “Program”) offered by Wizedemy Inc. d/b/a Wizeprep hosted on wizeprep.com, its respective subdomains, and third party hosting platforms (the “Site(s)”), are subject to these terms and conditions, including any refund policies and formulas that apply to Your specific Program and also Wizeprep’s Terms of Use (“Terms”).

If You purchase or enroll in the Program for use by another (for example, a parent consenting on behalf of a child) these Terms govern both You and other(s) who use the Program You purchase (collectively, “You”). Children under the age of 18 may only be enrolled in a Program through a purchase on their behalf by a Parent or guardian 18 years of age or older.

You agree to be bound by the Terms, which is an agreement between Wizeprep and You. This acknowledgment will be submitted as evidence in the event of any payment dispute.

Enrollment

Enrollment is for individual use only and may not be shared, transferred, or sold. If Wizeprep determines, in its sole discretion, that You have engaged in account sharing, misuse, or other violations of these Terms, Your access may be terminated without refund.

The earliest date on which You make a payment for a Program is Your original enrollment date (“Enrollment Date”) for that Program.

Enrollment in Programs with scheduled sessions is on a first-come, first-served basis. Wizeprep may close enrollment for any Program schedule at any time.

Payment

You must be paid in full or have financing in place and be up-to-date with any applicable payment schedule in order to access the Site and Your Program.

If You have any concerns about a transaction, You must contact Wizeprep Support at support@wizeprep.com.

Financing through third-party providers (e.g., Affirm, Partial.ly, etc.) is subject to their separate terms and conditions. All financing arrangements are solely between the customer and the applicable financing provider. Wizeprep is not responsible for any disputes, errors, decisions, or obligations related to financing with any third-party provider.

Financing through Wizeprep directly may be subject to additional terms and conditions.

Discounts

Only one discount, promotion, or coupon code may be applied per Program purchased.

Discounts cannot be combined or applied retroactively to prior purchases.

Discount eligibility may vary by promotion and is determined at Wizeprep's sole discretion. Wizeprep reserves the right to modify, limit, or withdraw discounts at any time.

Refunds

All Program purchases are final and non-refundable except as explicitly defined below for Programs with Performance Guarantees or unless otherwise specified below.

Refunds are not available for purchases made from resellers or other third party intermediaries.

Refunds are not available for unused Program resources such as unused tutoring hours, unused coaching sessions or unattended classes or events.

Access Period

You will have access to the Program:

- For up until six (6) months after the date of Your last scheduled class for Programs with course schedules. Content availability is at Wizeprep's sole discretion.
- For twelve (12) months from Your Enrollment Date for Self-paced Programs.
- For up until twelve (12) months from Your Enrollment Date for Private Tutoring Programs.

At its sole discretion, Wizeprep may make changes to the Program during Your access period. Some changes may impact Your access to past results.

Upon the expiration of Your access period, You will not be able to use the Program.

For all programs, You can extend Your access in accordance with the Unlimited Free Retake Policy as outlined below.

Scheduling, Rescheduling and Transferring

For Programs with course schedules

- You may select a specific course schedule relevant to Your Program on Your Enrollment Date, or

- You may defer Your course selection and later select any future schedule relevant to Your Program.
- If You defer Your course selection, You must select at least one course schedule within 24 months of Your Enrollment Date. If You do not select at least one schedule within 24 months of Your Enrollment Date, You may be required to pay an additional amount to select a future course schedule, subject to both course capacity and schedule availability at Wizeprep's sole discretion.
- If You wish to transfer to a different course schedule voluntarily (due to change in Your preferences, other commitments, etc.), You may request to do so at no charge, provided Your request is submitted 14 calendar days before the date of the first session of the course schedule You originally selected and that the new schedule starts no more than 24 months after Your Enrollment Date. All transfer requests should be submitted to support@wizeprep.com and are subject to course capacity and are approved at Wizeprep's sole discretion.
- Wizeprep reserves the right to cancel, reschedule, or amend the date and time of any individual session within a course schedule at its sole discretion; Wizeprep will notify You of any such changes at its sole discretion regarding the timing of the notice.

For Private Tutoring Programs:

- Tutoring sessions must be scheduled on a mutually convenient basis subject to tutor availability, and all requests must be submitted at least twenty-four (24) hours in advance.
- You will work with Your tutor to establish a mutually convenient schedule to complete the number of Program hours You purchased initially between Your Enrollment Date and Your desired completion date, subject to tutor availability. Wizeprep and its tutors reserve the right to cancel, reschedule, or amend session dates and times at their sole discretion.
- If You must revise this schedule due to changes in Your plans, any revised schedule should complete the number of Program hours You purchased initially within twelve (12) months of Your Enrollment Date. All private tutoring hours must be used within twelve (12) months of the date of purchase unless otherwise stated in writing. Extensions may be granted at Wizeprep's discretion upon written request.
- Wizeprep does not guarantee the continued availability of a specific tutor. You may be transferred to a new tutor during Your Program at Wizeprep's sole discretion.
- If You wish to voluntarily transfer to a different tutor, You must make the request immediately after Your first full session with the tutor. All transfer requests should be submitted to support@wizeprep.com and are subject to tutor availability and are approved at Wizeprep's sole discretion.
- At Wizeprep's sole discretion and subject to availability, a credit determined by Wizeprep for unused tutoring hours may be transferred and applied toward the purchase of other relevant Wizeprep Programs. Tutoring sessions are intended for content review and may not be used for other types of support, such as application or admissions consulting, unless specifically authorized by Wizeprep.

Cancellations

For Programs with course schedules

If a course schedule that You have selected is cancelled, You will be notified at Wizeprep's discretion in terms of the timing of the notice and at that time, You may either:

- Transfer into another available schedule, or
- If no available alternative meets Your needs, request a refund of Your Program fee (minus any amount paid on Your behalf for paid access to any third-party website which You have redeemed, any shipped physical textbooks You may have requested, and any other components of Your Program that You may have used, accessed, or activated).

For Private Tutoring Programs:

- Any session cancelled or rescheduled with less than twenty-four (24) hours' notice will be considered forfeited and deducted from Your available tutoring hours.
- Any session where You fail to join within fifteen (15) minutes of the start time without prior notification will be considered a "no-show" and forfeited; in the event of a late arrival, the session will conclude at the original scheduled end time and will not be extended.
- If Wizeprep cannot match You with a tutor to Your satisfaction for any reason within five (5) business days, You may choose to provide Wizeprep with additional time or view the Program as cancelled and request a refund of Your Program fee.

Upgrades

You may request to upgrade from one Wizeprep product or service to another by paying the price difference in effect at the time of the upgrade, plus any applicable taxes.

Unless explicitly confirmed in writing by Wizeprep, upgrades do not extend, renew, or restart Your initial access period as defined below.

To request an upgrade, please contact support@wizeprep.com. Wizeprep reserves the right, in its sole discretion, to determine eligibility for any upgrade and to approve or decline upgrade requests for any reason.

Unlimited Free Retake Policy

The Unlimited Free Retake Policy allows You to extend your Program access period in 6-month increments until You achieve Your Program goal score as long as You are using the Program for study and maintaining an active account with Wizeprep. Access period extensions do not include extended access to content provided through third-party websites.

Wizeprep may, at its discretion, require proof of Your continued preparation (such as confirmation of an upcoming test registration or other reasonable evidence) and require an online meeting over video conference or phone call to discuss Your specific situation before granting an access period extension.

If Wizeprep determines, in its sole discretion, that You have engaged in account sharing, misuse, or other violations of these Terms, You will lose eligibility for the Unlimited Free Retake Policy, and Your access may be terminated without refund.

Access period extension requests under this policy must be submitted to support@wizeprep.com, and must include an explanation of why the access period extension is requested and a copy of Your official score report if You took the actual test. All access period extension requests are subject to Wizeprep's review and may be approved or declined at Wizeprep's sole discretion.

For Programs with course schedules

Access period extensions under the Unlimited Free Retake Policy do not include enrollment in additional course schedules. You will have access to all Wizeprep Program content including recorded lessons.

For Private Tutoring Programs

Additional tutoring sessions are not included with access period extensions under the Unlimited Free Retake Policy. If You want additional tutoring sessions, You must purchase additional tutoring sessions separately.

Wizeprep Content and Use

All content and functionality in this Site and in our Programs, including all components of instructional and practice materials in all formats, all concepts and perspectives expressed therein, and all software, applications or other technology (collectively, the "Content"), except for materials accessed via Third-Party Websites as defined below, are owned by Wizeprep and are protected by copyright, trademark, patent, trade secret, and other intellectual property or proprietary rights laws.

Subject to Your compliance with these terms, Wizeprep grants You a personal, non-exclusive, non-transferable, revocable license to access and use the Site or, if applicable, the Programs only for Your own personal, non-commercial use. You must not reproduce, distribute, modify, create derivative works of, publicly display, publicly perform, re-publish, download, store or transmit any of the material on the Site, Programs or Content, except as follows:

- You may log in from up to two devices, but only one device may access Your account at a time.

- If we provide Content or applications for download, You may download a single copy to Your computer or mobile device solely for Your own personal, non-commercial use.

Program materials are provided in a digital format. Printed textbooks may be purchased during enrollment or by subsequent request to support@wizeprep.com, subject to availability. Shipping of physical materials is limited to addresses within the United States and Canada only. You are responsible for all associated costs, including shipping charges, duties, and tariffs, all of which are non-refundable.

Copyright Infringement and DMCA Policy

Wizeprep respects the intellectual property rights of others and requires all users of the Site and Programs to do the same. In accordance with the Digital Millennium Copyright Act (“DMCA”) and other applicable intellectual property laws, we have instituted procedures to receive and process written notifications of claimed infringements. Notice of Infringement Requirements

Coaching Sessions

Miscellaneous

These Terms supersede all prior oral or written agreements and constitute the entire agreement between Wizeprep and You. Terms cannot be changed or modified orally. If any provision of Terms is found to be unenforceable for any reason, such provision shall be construed by limiting it to make it enforceable to the maximum extent permitted by law, and the remainder of Terms shall continue in full force and effect.

Dispute Resolution and Binding Arbitration

Any and all disputes, claims, or controversies arising out of or related to these Terms and Conditions, Your Program, or the breach, termination, enforcement, interpretation, or validity thereof, shall be finally resolved by binding arbitration administered by a neutral arbitrator in accordance with the laws of British Columbia. The arbitration shall take place in Vancouver, British Columbia, unless otherwise agreed by the parties. Judgment on the arbitral award may be entered in any court having jurisdiction thereof. Notwithstanding this agreement to arbitrate, You and Wizeprep both retain the right to bring an individual action in a small-claims court of competent jurisdiction in Vancouver, British Columbia, for disputes within the scope of such court's jurisdiction.

Class Action and Jury Trial Waiver

To the maximum extent permitted by applicable law, You and Wizeprep agree that any proceedings to resolve or litigate any dispute will be conducted solely on an individual basis. You waive any right or ability to be a class or collective action representative or to otherwise participate in any putative or certified class, collective, or multi-party action or proceeding against Wizeprep. Neither You nor Wizeprep shall be entitled to join or consolidate claims by or against other customers in court or in arbitration. Furthermore, both parties voluntarily and irrevocably waive any right to a trial by jury in any legal proceeding arising out of or related to these Terms and Conditions.

Governing Law and Jurisdiction

These Terms and Conditions, and any claim or dispute arising between You and Wizeprep, shall be governed by and construed in accordance with the laws of the Province of British Columbia and the federal laws of Canada applicable therein, without regard to principles of conflicts of law. Except for matters subject to arbitration as described above, You hereby irrevocably consent to the exclusive jurisdiction of the provincial and federal courts located in Vancouver, British Columbia, for the resolution of any litigation.

Acceptance of These Terms and Conditions

MCAT Elite 515 Course Performance Guarantee

The MCAT Elite 515 Course Performance Guarantee provides a partial refund based on Your actual payment (for clarity: not based on the advertised, undiscounted price of the MCAT Elite 515 Course) and calculated with reference to a) the formula below, b) Your official MCAT® score (taken after the completion of Your course and documented as detailed below) and c) Your Diagnostic Exam score. (The Diagnostic Exam is assigned in Your MCAT Elite 515 schedule and must be completed within 7 calendar days of the assignment date for Your Diagnostic Exam in Your MCAT Elite 515 schedule or as otherwise instructed in the course by Wizeprep staff.)

Eligibility Requirements
